As part of our Policy and Evaluation work, INCORE has sought to chart the growth in number, size, effect and influence of NGOs over the past few decades. This book examines how NGOs seek to influence policy and the challenges they face in terms of resources and retaining independence while engaging with policymakers on crucial issues.


Former INCORE Director Professor Mari Fitzduff co-edited the book. She said:
